Details of the pre-application advice received

The applicant and the applicant's agent have met with the planners on several occasions to discuss the proposals for this particular site. The applicant and agent met with Simon Gale and Gareth Davies, council planners, and council representatives for highways and education. Further details of these discussions can be found within the 'Design and Access Statement'. However, the last meeting in May was how the final iteration of the development was formed, with provision for a two form entry primary school agreed. Furthermore, numerous discussions between the applicant's transport consultant and the council's representative for Highways for the proposed vehicular access off Llantrisant Road resulted in an acceptable solution. Therefore, based upon these discussions, the applicant is formally progressing with an outline application for up to 125 dwellings accessed via Llantrisant Road, with land reserved for a possible primary school
